

San Antonio's Safest Driver Promotion Official Rules

(Sweepstakes rules begin on page [9])

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW OR REGULATION. PARTICIPANTS MUST BE 18 YEARS OF AGE OR OLDER AT THE TIME OF ENTRY.

San Antonio's Safest Driver Promotion (the "Promotion") is a non-gambling contest of skill and is intended for roadway safety research purposes.

Entry in the Promotion does not constitute entry into any other promotion, contest, or sweepstakes. Each person who downloads the San Antonio's Safest Drive mobile application for the Promotion ("App") enters the Promotion.

Each individual who participates ("Entrant") in the Promotion unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of the City of San Antonio of {100 Military Plaza, San Antonio, TX 78205} ("Administrator"), CMT of {101 Main Street, 14th Floor, Cambridge MA 02142} ("App Administrator"), and teamDigital Promotions, Inc. of {6 Berkshire Blvd., Bethel, CT 06801} ("Prize Administrator") whose decisions shall be final and legally binding in all respects and not subject to additional review. The sponsor of the Promotion is United Services Automobile Association ("Sponsor") of {9800 Fredericksburg Road, San Antonio, TX 78288}.

Official Rules – Contest of Skill

1) Description: The Promotion is based on each Entrant's bi-weekly results while using the App. From the time they download the App, Entrants will be scored bi-weekly in the following three (3) categories: i) Safest Driver; ii) Safest Military Driver; and iii) Least Distracted Driver (each, a "Category"). During the First Prize Promotion Period (defined in Section 3), the Entrants with the highest scores at the conclusion of each Entry Period (defined in Section 3) in each Category will be named First Prize winners. During the Grand Prize Promotion Period (defined in Section 3), the Entrants with the highest total scores in each Category will be named Grand Prize winners.

2) Eligibility: The Promotion is open to residents of the State of Texas residing within one (1) of the participating zip codes ("Zip Codes") as indicated in Section 14 of these Official Rules, who are eighteen (18) years of age or older as of the date of entry.

Employees, officers, directors, agents, and representatives of the Administrator are eligible to participate, but ineligible to win. Employees, officers, directors, agents and representatives (and the respective children or legal wards of each) of the Sponsor, App Administrator, and Prize Administrator and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representatives and employees), and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, suppliers, advertising and promotion agencies (hereafter collectively **with the Administrator**, “Released Parties”), and any such individual’s immediate family members (mother, father, sister, brother, daughter, son and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, are eligible to participate, but ineligible to win. Void outside of the participating Zip Codes and where prohibited by law. All applicable federal, state and local laws apply.

3) Promotion Periods: The First Prize promotion period begins at 11:59:59am Central Time “CT” on 6/11/18 and ends at 11:59:59pm CT on 9/2/18 and will consist of six (6) entry periods (hereafter each an “Entry Period” and collectively, the “First Prize Promotion Period”) as indicated in the below chart.

The Grand Prize promotion period begins at 12:00:00pm on 7/8/18 and ends at 11:59:59pm on 9/2/18 (“Grand Prize Promotion Period,” together with the First Prize Promotion Period, the “Promotion Periods”).

4) How to Enter: To participate during the First Prize Promotion Period and/or the Grand Prize Promotion Period, download the App on your wireless mobile device (if you have not done so already) and follow the prompts to complete the registration form inclusive of your participating Zip Code, age, email address, and military status. By downloading the App and registering during a Promotion Period, you agree to be bound by these Official Rules and all decisions of Administrator, which are final and binding. To activate your

App and begin participating in the Promotion, you must begin a trip via your vehicle. A trip will be defined by traveling via a vehicle with you as the driver ("Trip"). The App will automatically activate a Trip when it senses movement of your vehicle and the Trip will automatically end after five (5) consecutive minutes of no movement. Once a Trip has been automatically submitted to the App, the Entrant will receive one (1) entry. Entrant cannot access/revise entry in any way.

Additional entries received from the same person/email address in excess of the stated limitation will be void. All entries become the exclusive property of the Administrator and will not be acknowledged or returned. The use of script, macro, or automated devices (or any other devices intended to automate or subvert any aspect of entry) to enter the Promotion is prohibited and any entry through such means and any entry that is deemed to be ineligible (at Administrator's sole discretion and in accordance with the Official Rules) are void. In the event of a dispute as to the identity of an Entrant, entry will be awarded to the authorized account holder of the email address associated with the App. The "authorized account holder" is deemed as the natural person who is assigned to an email address by an Internet access provider, service provider or other online organization that is responsible for assigning email addresses for the domain associated with the submitted e-mail address. A potential winner may be requested to provide Administrator with proof that the potential winner is the authorized account holder of the email address associated with the winning entry. Released Parties are not responsible for late, lost, stolen, incomplete, misdirected, delayed, garbled, inaccurate, destroyed or undelivered entries, App downloads or registrations, or for telephonic, human or computer failures, problems or errors, interruptions in service due to system upgrades, repairs, modifications or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones/mobile device (including wireless phones/handsets or other wireless devices), phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with the Promotion, including, without limitation, errors which may occur in connection with the administration of the Promotion, the processing of entries, the tabulations of App points/scores, the functionality of the App or the announcement of the prizes; or for any injury or damage to Entrant's or any other person's computer or mobile device relating to or resulting from participation in this Promotion or use of the App, or for printing, typographical, human or other errors appearing in these Official Rules or other Promotion-related materials. Entrants are responsible for any charges of online service

providers or wireless carriers. Administrator reserves the right, in its sole discretion, to void any entries of Entrants whom Administrator believes have attempted to tamper with or impair the administration, security, fairness or proper play of this contest or is in violation of these Official Rules.

Information submitted via the App that is shared with the Released Parties for purposes of this Promotion will be subject to and used in a manner consistent with these Official Rules.

5) Points and Scoring: Skill based points will be determined by the App based on individual driving skills as determined by the App's exclusive methodology. The methodology monitors the frequency and acceleration intensity, braking intensity and frequency, average speed of the vehicle in relation to posted speed limits, along with interaction time with phone while vehicle is moving. Entrants will receive a rating between 1-5 (5 being the highest) and suggestive correction action (if applicable) after each Trip in each of the following categories: i) braking, ii) acceleration; iii) cornering; iv) speeding; and v) phone distraction. A 5-star rated Trip means the Entrant scored highly in all categories. A user will receive a driving score ("Driving Score") after one (1) Trip has been completed. At the conclusion of each Entry Period, the Driving Score is calculated (highest score possible is 100). No Driving Score points from one Entry Period will roll over to any other Entry Period, with the exception of the Grand Prize Promotion Period.

6) Winner Determination/Notification: At the conclusion of each Entry Period in the First Prize Promotion Period (on/about the date indicated in the chart in Section 2 of these Official Rules), the three (3) Entrants with the highest scores in each Category will be named the potential First Prize winners (subject to verification) for a total of fifty-four (54) First Prize winners.

At the conclusion of the Grand Prize Promotion Period on/about 9/7/18, the one (1) Entrants with the highest score in each Category will be named potential Grand Prize winners (subject to verification) for a total of three (3) Grand Prize winners.

In the event of a tie for any Category prize, ties will be broken by the most miles driven within Bexar county zip codes. In order to be qualify for a Safest Military Driver prize, Entrants must serve/have served in the military.

7) Prizes and Prize Notification: Fifty-four (54) First Prizes: Each First Prize winner will receive \$500 in the form of a check. Approximate Retail Value ("ARV") = \$500 each.
Three (3) Grand Prizes: Each Grand Prize winner will receive \$10,000 in the form of a

check. All prize details will be determined by Administrator in its discretion. Costs and expenses associated with the acceptance and use of a prize not specified herein as being awarded, including, but not limited to, all federal, state and local taxes are each winner's sole responsibility. Total ARV of all aggregated prizes: \$57,000.

There is a limit of one (1) First Prize per person. Potential winners will be notified by email and must respond within five (5) calendar days from the date of notification or such winner(s) may be disqualified and the prize at hand awarded to an alternate winner. Administrator may require each potential winner to provide evidence of eligibility (photocopy of a valid driver's license or other government-issued identification) and contact details (including, without limitation, a valid e-mail address, mailing address and telephone number) to enable Administrator to award a prize to the potential winner in accordance with the Official Rules. Administrator reserves the right (at its sole discretion) to disqualify any potential winner, if a potential winner is determined to be ineligible to participate and/or win a prize. Unless prohibited by law, potential Grand Prize winners will be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release and potential First Prize winners may be required to execute and return a Prize Claim Form within five (5) days of date of issuance of notification. If a potential winner fails to respond within the specified time period or cannot be contacted; is ineligible according to these Official Rules; fails to return the required documents within the specified time period; or Administrator's sending of the required documents are returned as undeliverable; if any potential winner decides to decline a prize for any reason whatsoever; or if any potential winner otherwise fails to fully comply with these Official Rules, he/she will forfeit his/her prize and the prize may be awarded to an alternate winner from among all remaining eligible entries received, in the Administrator's sole discretion. Once the completed and required paperwork is received within the specified time period, verified, and Administrator reviews and approves, then and only then will a potential winner be designated a winner in the Promotion. Administrator assumes no responsibility for an undeliverable prize resulting from a typographical error or change of address of Entrant. Prize award is subject to verification of eligibility and compliance with these Official Rules.

8) Data Collection: During signup, Entrants will be required to create a username (to be shown on leaderboards) and provide their primary zip code (to group them on a specific leaderboard with their neighbors), email address (to notify winners or reset passwords if obtaining a new phone during the competition), age range (such as 18-24), and if they are a military member and their branch. All data collected at time of registration will be used

(1) to power the contest and prizes in addition to providing further insights into roadway safety research and (2) by App Administrator in accordance with the App's privacy policy, available for viewing at www.cmtelematics.com/company/privacy.

The Promotion aims to help people driving on city streets to be safer drivers in support of Vision Zero, an initiative by the Administrator (for more information, see <http://www.sanantonio.gov/TCI/Vision-Zero>). Outside of the Promotion, the Administrator collects speed, traffic volume, and crash data. The data collected through the Promotion will complement the Administrator's data and help the Administrator learn more about how to improve safety along our roadways.

By downloading and participating in the Promotion, you agree to share registration and driving data with the App Administrator. Your registration data includes e-mail address, zip code, age bracket, and/or military status. Your driving data includes your speed, acceleration, braking, cornering, and phone usage as it pertains to the App's scoring method. You also acknowledge and agree that the Administrator and Sponsor may review and analyze the de-identified and aggregated driving and registration data.

9) Miscellaneous: By downloading the App and participating in the Promotion, each Entrant accepts and agrees to accept and be bound by these Official Rules and by the decisions of the Administrator, which shall be final and binding in all respects. No transfer, assignment, cash redemption, or substitution of a prize (or portion thereof) is permitted except by Administrator who reserves the right to substitute a prize (or portion thereof) with one of comparable or greater value as determined by Administrator. All federal, state, and local taxes (including income and withholding taxes) and all other costs and expenses associated with acceptance and use of a prize not specified herein as being awarded are winners' sole responsibility. Except where prohibited by law, a prize winner's acceptance of a prize constitutes permission for the Released Parties to use that prize winner's name, photograph, likeness, statements, biographical information, voice, and address (city and state) worldwide and in all forms of media, in perpetuity, without further compensation. Prize winners agree to Released Parties' use of their names and likeness for advertising and publicity purposes, without additional compensation, unless prohibited by law. The Released Parties are not responsible for lost, incomplete, inaccurate, garbled, late, delayed, undelivered or misdirected downloads, installations, registrations, usernames, scores; failures or malfunctions of phones/mobile devices (including wireless phones/handsets or other wireless devices), phone lines or telephone systems; interrupted or unavailable network, server or other connections; any error, omission, interruption, defect or delay

in any transmission or communication; traffic congestion on the Internet or for any technical problem, including, but not limited to, any injury or damage to Entrant's or any other person's computer or mobile device related to or resulting from participation in this Promotion; errors or ambiguity in these Official Rules, in any Promotion-related advertisements or other materials; the selection or announcement of potential winners or the distribution of prizes; the problems or errors of any kind whether mechanical, human, electronic, typographical, printing or otherwise. By entering, each Entrant agrees that the Released Parties shall have no liability and will be held harmless by Entrant for any claim, action, liability, loss, injury or damage (1) to Entrant or any other person or entity, including, without limitation, personal injury or death to Entrant or any other person or damage to personal or real property, due in whole or in part, directly or indirectly, by reason of the acceptance, possession, use or misuse of any prize or participation in this Promotion, and (2) any and all taxes and other fees applicable to the prizes received by the prize winners. 10) Arbitration: Except where prohibited by law, as a condition of participating in this Promotion, Entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this Promotion, or any prizes awarded, shall be resolved

individually, without resort to any form of class action, and exclusively by final and binding arbitration under the rules of the American Arbitration Association and held at the AAA regional office nearest the Entrant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to claim, punitive, incidental or consequential damages, or any other damages, including attorneys' fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with participating in this Promotion), and Entrant further waives all rights to have damages multiplied or increased.

11) Choice of Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Entrant, Administrator, and Released Parties in connection with the Promotion, shall be governed by, and construed in accordance with, the substantive laws of the State of Texas, USA.

3) How to Enter: There are two (2) ways to enter during the Promotion Period:

Mobile App: Install the San Antonio’s Safest Driver application (“App”) using a compatible device by going to the Apple App Store or Google Play, as applicable, and follow the instructions to download and install the App. All information submitted via the App is subject to, and will be treated in a manner consistent with, the Application Terms and Conditions accessible within the App and the App’s privacy policy, available for viewing at www.cmtelematics.com/company/privacy/; all information submitted via the App that is shared with the Administrator and Sponsor for purposes of this Sweepstakes will be subject to and used in a manner consistent with these Official Rules.

Mail-in: To receive one (1) entry without downloading the App, neatly hand-print or type your complete name, address, city, state, zip code, date of birth, daytime telephone number (including area code), and email address on a plain 3" x 5" piece of paper and mail it in an envelope with proper postage to: San Antonio’s Safest Driver Entry, San Antonio’s Safest Driver Sweepstakes, 211 Greenwood Ave 2-2, Promo 515, Bethel, CT 06801. Potential winners will be notified by email and must respond within five (5) calendar days from the date of notification or such winner(s) may be disqualified and the prize at hand awarded to an alternate winner.
